On 03-28-2020, at approximately 2345 hours, I observed activity where people were inside Champions Bar at 302 S. Main St.

The front doors were locked and all the blinds were lightly closed on all windows preventing anyone to see in. Two vehicle's were parked out front of the buisness and they have been seen there all week. On 03-23-2020 at approximately 0000 hours, I observed three people leave the buisness and drive away in the same vehicles. The buisness was to remain closed by orders of the mayor and governor.

I walked to the north exit doors on E. 3rd street and observed the door was unlocked and 4 people were sitting at a table inside. I knocked on the door and three people got up and carried there drinks away.

Makayla Roundy came to the door and spoke with me. Roundy identified herself as the manager of the buisness. While speaking with Roundy, I could smell a strong odor of alocohol coming from her breath. Roundy stated there were only three other people in the bar and they were friends. I asked Roundy if she was charging them for drinks and Roundy stated no. Roundy then stated they were not drinking.

Roundy stated the owner of the buisness did not know she was there.

I informed Roundy the buisness was ordered closed, even to private events. Roundy stated she would lock up and leave.

Narrative:

Information:

On 04/16/2020 I was given an email from the Mayor of the City of Moscow stating a city patron witnessed individuals eating inside of restaurants. The patron stated there was 15 people inside Humble Burger waiting for their meals. They also stated Humble Burger did not have curbside pickup or delivery. They added Bucers was allowing large groups of individuals inside as well as Tapped and Mingles letting people eat inside the restaurant.

I contacted Tyler M Antkowiak at Tapped, who stated he was the manager. Antkowiak told me they have been within the standards of the City order. Antkowiak told me employees eat inside the restaurant while they are on their break but that was it. Cpl. Davis took pictures of the inside of the restaurant and attached them to this case to show the restaurant is within compliance.

I spoke to Patricia Greenfield, the owner of Bucers, over the phone who told me they had been working within the regulations. Greenfield told me she would let a very small group of individuals sit inside the restaurant and wait for their food. Greenfield said "having to tell a man he could not sit and wait for his food was embarrassing". Greenfield told me she spoke to Laurie Hopkins who told Greenfield it was acceptable to allow patrons to sit and wait for their food as long as there was no more than 10 people. I was not able to take pictures of Bucers due to a high priority call was dispatched while I was speaking to a Bucers employee.

I spoke to Gabe H Stevens at Humble Burger about the concerns of allowing patrons to sit inside and eat their meals, along with not having curbside pick up. As I approached Humble Burger it was apparent they had a curbside pick up sign located on the south side of the building. Stevens told me they had been operating within regulations. All chairs were on top of the tables inside Humble Burger.

I spoke to Mike D Boyd at Mingles who told me they were operating within regulations. Boyd said they do not allow patrons to eat inside. Boyd said they allow food to go and alcoholic beverages to go. Inside Mingles the pool tables were covered with miscellaneous items. Cpl. Davis attached pictures of the inside of Mingles to show their compliance with the regulations.

Information was passed onto the night patrol shift and asked to reinspect the businesses an alternate time.
